**Art & Craft Show Rules of Entry**

June 29<sup>th</sup> 2008

10:00am – 4:00pm

The purpose of our Fair is to focus on handcrafted items and talents, to provide a market for such items and talents and to show case Lost Art demonstrations and crafts. It is our policy to separate booths selling non-handcrafted items from those selling handcrafted items. Therefore, we ask for honesty when you fill out your application for booth space. Items not included in handcrafted include *pre-purchased, imported or mass produced items*. Please be advised that if a vendor is selling non-handcrafted merchandise in the handcrafted area, they will be asked to move or leave without a refund. Thank you in advance for helping us to avoid such an incident. We will attempt to locate everyone in a manner that all visitors will see their booth.

**Display Areas are 12' X 12' (Enlarged from last year):** Participants are responsible for furnishing their own display tables, chairs, etc., and for clean up of their area after the fair. Under no circumstances will the Chamber be liable for loss of or damage to work or display material. *Except in the event of severe weather, exhibitors may not dismantle their booths before 4:00pm, the end of the Fair.* A cash prize drawing will be held at 4:00 pm for all vendors.

**Applicable sales tax:** Collection of State and County (Vilas) sales tax (5.5%) is the responsibility of the exhibitor.

**Entries & Check-in:** Booths will be assigned as entries are received. Please let us know of any special consideration you may have, understanding that electricity and access to water are very limited. Every effort will be made to satisfy each request for a “special space”. Check-in time is 7:00am on the day of the Fair on Main Street.
